

ORDINANCE NO. 1 CITY OF LYNNWOOD City of Lynnwood DEC 3 0 2002 SCANNED

An ordinance declaring the Incorporation of the City of Lynnwood, Washington, and the election of officers thereof.

THE CITY COUNCIL OF THE CITY OF LYNNWOOD DO ORDAIN AS FOLLOWS:

Sec. 1. That pursuant to the laws of the State of Washington, at a special election held for that purpose on the 14th day of April, 1959, within the boundaries of the area hereinafter described. The qualified electors, by a majority of the votes cast therein, voted that said area be incorporated as a City of the Third Class. That said area is described as follows: Sec. 2. That the following seven candidates for the office of City Councilman received the highest number of votes cast at the aforesaid special election:

> Erwin Buxton William H. Chadwick N. Richard "Dick" Forsgren Dean Guth Edward R. Martin Harry H. Moore Harry M. Morrison

Sec. 3. That the candidate Jack Bennett received the highest number of votes cast at the aforesaid special election for the office of Mayor.

Sec. 4. That the candidate Leon Russell Haggard received the highest number of votes cast at the aforesaid special election for the office of City Clerk.

Sec. 5. That the candidate Edith A. Smith received the highest number of votes cast at the aforesaid special election for the office of City Treasurer.

Sec. 6. That the candidate J. Gaylord Riach received the highest number of votes cast at the aforesaid special election for the office of City Attorney.

Sec. 7. That the Board of County Commissioners of Snohomish County, Washington, on the 16th day of April, 1959, duly passed a resolution declaring that the area described in Sec. 1 herein was incorporated as a City of the Third Class, declaring the election of the persons named in Sec. 2 herein as City Councilmen for said incorporated area; declaring the person named in Sec. 3 herein as the Mayor of the City of Lynnwood; declaring the person named in Sec. 4 as the City Clerk; declaring the person named in Sec. 5 as the City Treasurer; declaring the person named in Sec. 6 as the City Attorney; that the aforesaid resolution was duly entered in the minutes of the said Board of County Commissioners

on the 16th day of April, 1959, and filed in the office of the Secretary of State on the 20th day of April, 1959.

Sec. 8. This ordinance shall take effect and be in force five days after its passage, approval and publication.
