SECTION 3. That Section 2.48.190, Salaries and Wages for compensation based on flat rate, be amended to read as follows:

Section 2.48.190, Salaries and Wages for compensation based on flat rate. Salaries or wages are established as follows for the various classes of positions in employment as set forth below:

(a) Mayor

\$ 3,565 per month

(b) Reserve Police Officer

4.00 per hour

(c) Part-paid Firefighter

4.00 per hour

SECTION 4. That Section 2.48.192, <u>Compensation for Council</u>, be amended to read as follows:

Section 2.48.192, <u>Compensation for Council</u>. Each person elected to serve as a member of the <u>Council for the City of Lynnwood shall receive as compensation for service to the City of Lynnwood a base payment per month, plus a "per meeting" payment for each Council meeting attended, as per the following schedule:</u>

Councilmembers shall be entitled to receive reimbursement for expenses actually incurred in attending functions when such functions are official City business. Councilmembers may be reimbursed for educational programs attended by them, designed to inform the Council to ways to better serve the City of Lynnwood.

SECTION 6. This ordinance shall take effect and be in force January 1, 1982.
