ORDINANCE NO. 1287

AN ORDINANCE AMENDING SECTION 18.20 OF THE LYNNWOOD MUNICIPAL CODE AND THE COMPREHENSIVE PLAN AND AMENDING THE OFFICIAL MAP OF THE COMPREHENSIVE PLAN MAP FOR THE CITY AND ADOPTING OFFICIAL MAPS AS ADDITIONS TO THE COMPREHENSIVE PLAN MAP FOR THE CITY OF LYNNWOOD.

WHEREAS, after due notification, hearing and deliberation, the Planning Commission of the City of Lynnwood recommended Findings of Fact and Conclusions of Law in favor of the proposed Comprehensive Plan change; and

WHEREAS, the City Council of the City of Lynnwood deemed it necessary to hold an additional hearing on the proposed Comprehensive Plan change; and

WHEREAS, after due notice, hearing and deliberation the City Council adopted Findings of Fact and Conclusions of Law approving the proposed Comprehensive Plan change as being in the best interests of the City;

NOW, THEREFORE, the City Council of the City of Lynnwood do ordain as follows:


<u>SECTION 1.</u> That Chapter 18.20 of the Lynnwood Municipal Code and the official map of the Comprehensive Plan of the City of Lynnwood and the Comprehensive Plan of the City of Lynnwood should be and the same are hereby amended as set forth in this ordinance. That insofar as the Comprehensive Plan map of the City of Lynnwood conflicts with the maps hereafter adopted by this ordinance the same should be and is hereby repealed.

SECTION 2. That the official map of the Comprehensive Plan of the City of Lynnwood is hereby amended by adding a Scriber Creek Trail Corridor in areas throughout the City of Lynnwood as delineated upon that certain map attached hereto as "Exhibit A"*and by this reference incorporated herein and the official Comprehensive Plan and the Comprehensive Plan map of the City of Lynnwood should be in the same are hereby amended in accordance with the proposed Scriber Creek Trail Corridor as set forth on said attached map.

SECTION 3. Severability - If any section, subsection, sentence, clause, phrase or word of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality thereof shall not affect the validity or constitutionality of any other section, subsection, sentence, clause, phrase or word of this ordinance.

SECTION 4. This ordinance shall take effect five (5) days after its passage, approval and publication.

*The reproduction of the map incorporated by this reference as Exhibit "A" would be meaningless to the general public. The full map is available at Lynnwood City Hall for review by anyone who desires to do so.


