

AN ORDINANCE AMENDING ORDINANCE NO. 219 AND TITLE 11.44 OF THE LYNNWOOD MUNICIPAL CODE BY ESTABLISHING PARKING RESTRICTIONS ON CERTAIN STREETS DURING CERTAIN HOURS AS AUTHORIZED BY RCW 46.90.270

WHEREAS, RCW 46.90.270 does grant local authority to prohibit, regulate or limit stopping, standing or parking of vehicles on any highway at all times or during such times as shall be indicated by official traffic control devices after the completion of a traffic investigation by the Traffic Engineer; and

WHEREAS, the City Council of the City of Lynnwood did request the Public Works Director, acting as the City Traffic Engineer, to conduct a traffic study of the parking situation on 202nd Street S.W. between Highway 99 and 68th Avenue West as prescribed by R.C.W. 46.90.270; and

WHEREAS, the traffic investigation did indicate that traffic safety problems occur because of the presently allowable parking along 202nd Street S.W. between Highway 99 and 68th Avenue West; and

WHEREAS, it was the conclusion of the traffic investigation that further parking restrictions should be enacted along certain sections of 202nd Street S.W. between Highway 99 and 68th Avenue West.

NOW, THEREFORE THE CITY COUNCIL OF THE CITY OF LYNNWOOD DO ORDAIN AS FOLLOWS

SECTION 1. That Title 11.44.010 of the Lynnwood Municipal Code which reads as follows:

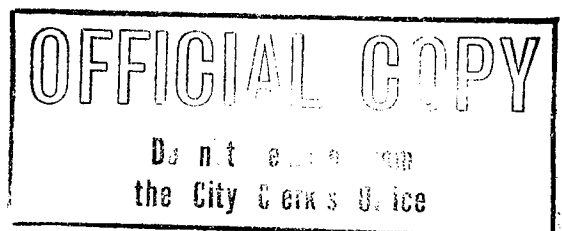
11.44.100 Parking Prohibited During Certain Hours on Certain Streets. When signs are erected giving notice thereof, no person shall park a vehicle at any time on either side of 68th Avenue West from 196th Street S.W. to 204th Street S.W. other than commencing at midnight Friday to midnight Sunday, or as may be specifically otherwise posted.

SHOULD BE AND THE SAME IS HEREBY AMENDED TO READ AS FOLLOWS:

11.44.100 Parking Prohibited During Certain Hours on Certain Streets.
When signs are erected giving notice thereof, no person shall park a vehicle at any time on either side of the street on

- a. 68th Avenue West from 196th Street S.W. to 204th Street S.W. other than commencing at midnight Friday to Midnight Sunday.
- b. 202nd Street S.W. from Highway 99 to 68th Avenue West between the hours of 8:00 a.m. and 7:00 p.m. other than commencing at 8:00 a.m. on Saturday to 7:00 p.m. Sunday.

or as may be specifically otherwise posted.




SECTION 2. That appropriate signs giving notice of these parking restrictions shall be posted as prescribed by Title 11.44.130 Lynnwood Municipal Code.

SECTION 3. That all ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed.


SECTION 4. This ordinance shall take effect and be in full force five days after its passage, approval, and publication.

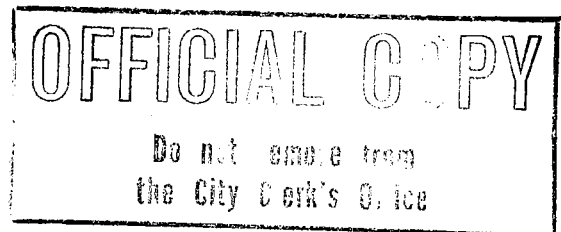
