ORDINANCE NO. 1622

AN ORDINANCE OF THE CITY OF LYNNWOOD FIXING THE TIME AND PLACE OF MEETINGS OF THE CITY COUNCIL OF THE CITY OF LYNNWOOD AND AMENDING ORDINANCE NO. 1503 AND LYNNWOOD MUNICIPAL CODE CHAPTER 2.04 OF THE CITY OF LYNNWOOD, ALL IN ACCORDANCE WITH R.C.W. 35A.12.110.

THE CITY COUNCIL OF THE CITY OF LYNNWOOD DO ORDAIN AS FOLLOWS:

SECTION 1. That Section 2.04.010 of the Lynnwood Municipal Code, which reads as follows, to wit:

2.04.010 TIME AND PLACE OF MEETINGS

The City Council shall meet on the second and fourth Monday of each calendar month at 7:30 p.m. in the Council Chambers at the Civic Center of the City of Lynnwood, or at such other place as the Mayor shall direct at the previous regular meeting or publish notice of according to law.

IS HEREBY REPEALED, REVISED AND AMENDED TO READ AS FOLLOWS:

2.04.010 TIME AND PLACE OF MEETINGS

The City Council shall meet on the second and fourth Monday of each calendar month at 7:30 p.m. in the Council Chambers at the Civic Center of the City of Lynnwood, or at such other place or time as the City Council shall direct at the previous regular meeting and publish notice according to R.C.W. 35A.12.110.

SECTION 2. That Section 2 of Ordinance No. 1503, which reads as follows, to wit:

SECTION 2. That in addition to the regular Council meetings set by Ordinance, the City Council shall meet on the first, third, and fifth Mondays of each month, for a work session.

IS HEREBY REPEALED, REVISED AND AMENDED TO READ AS FOLLOWS:

SECTION 2. That in addition to the regular Council meetings set by Ordinance, the City Council may meet on the first, third, and fifth Mondays of each month, for a work session or at such other place or time as the Council shall direct.



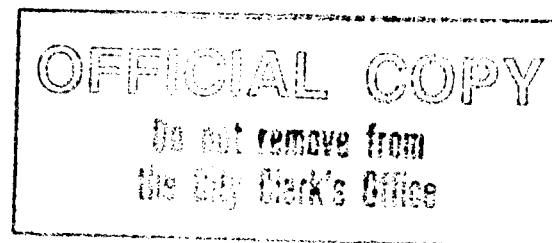
