AN ORDINANCE AMENDING LYNNWOOD MUNICIPAL CODE SECTION 13.20.10 "CHARGES FOR DOMESTIC WATER", ELIMINATING CHARGES FOR FIRE SERVICE CONNECTIONS; ESTABLISHING AN EFFECTIVE DATE AND AUTHORIZING SUMMARY PUBLICATION.

**WHEREAS**, the Lynnwood City Council adopted Ordinance 1927 amending water service fees and charges on December 14, 1992; and

**WHEREAS**, it is deemed to be in the public's best interest to encourage the establishment of fire protection systems; and

**WHEREAS**, the Public Works Director and City Fire Marshall have both recommended discontinuing the charge for fire service connections; now, therefore

**THE CITY COUNCIL OF THE CITY OF LYNNWOOD DO ORDAIN AS FOLLOWS:**

SECTION 1 The Lynnwood Municipal Code Section 13.20.10 is hereby amended to read as follows:

**13.20.010 CHARGES FOR DOMESTIC WATER**

The charges for domestic water service shall be based upon the size of meter installation, number of connection or units being serviced therefrom, and the water delivered through the service meter; the monthly rate for each meter size and the maximum water allowed as part of this minimum charge shall be:



SECTION 2 This ordinance shall take effect and be in force January 15, 2001 which shall be more than five (5) days after its passage, approval and publication. Publication shall be by a summary consisting of the Ordinance title.
