

#### **ORDINANCE NO. 3273**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LYNNWOOD, WASHINGTON, RELATING TO FEES FOR CITY SERVICES, AMENDING CHAPTER 3.104 LMC, AND PROVIDING FOR AN EFFECTIVE DATE, SEVERABILITY AND SUMMARY PUBLICATION.

WHEREAS, fees for City services are authorized by the Lynnwood Municipal Code (LMC), and are codified as Chapter 3.104 LMC, which is generally referred to as the "Fee Schedule"; and

WHEREAS, the Fee Schedule is revised periodically to address changing conditions, as evidenced by 19 amendments enacted during the years 2007 through 2016, with the most-recent amendment set forth by Ordinance 3237, which was approved by the City Council on November 28, 2016; and

WHEREAS, EHB 1595, passed by the 65<sup>th</sup> Legislature and signed into law by Governor Inslee, provides new provisions for fees that may be imposed by public agencies for records provided pursuant the Public Records Act; and

WHEREAS, amendment of the City of Lynnwood Fee Schedule is necessary to establish consistency with the provisions of EHB 1595; and

WHEREAS, due to inadvertent error during a previous amendment of the Fee Schedule, LMC 3.104.210 contains fees unrelated to the provisions of Title 21 LMC and it is appropriate to improve the accuracy of the Fee Schedule by remedying this condition; and

WHEREAS, as the provisions of this ordinance do not relate to comprehensive plans or development regulations, and therefore notification of State agencies as specified by RCW 36.70A.106 and WAC 365-196-630 is not required; and

WHEREAS, the provisions of this ordinance are procedural in nature and are exempt from SEPA threshold determination and EIS requirements as specified by to WAC 197-11-800(19); and

WHEREAS, the City Council has determined that the provisions of this ordinance are in the interest of the public's health, safety and general welfare;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LYNNWOOD, WASHINGTON, DO ORDAIN AS FOLLOWS:

**Section 1:** LMC 3.104.210 is amended to read as provided by Exhibit A to this ordinance.

Section 2: Chapter 3.104 LMC is amended to include the provisions of Exhibit B to this ordinance.

<u>Section 3</u>: Codification. The provisions of Exhibit B as adopted by Section 2 of this ordinance shall be codified as LMC 3.104.020.

**Section 4:** Effective Date of Amendment and Adoption. This ordinance shall become effective five days following passage and publication of this ordinance.

<u>Section 5</u>: <u>Severability</u>. If any section, subsection, sentence, clause, phrase or word of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality thereof shall not affect the validity or constitutionality of any other section, subsection, sentence, clause, phrase or word of this ordinance.

**Section 6:** Summary Publication. Publication of this ordinance shall be by summary publication consisting of the ordinance title.
