

ORDINANCE NO. 3353

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LYNNWOOD, WASHINGTON, RELATING TO FEES CHARGED BY THE CITY, INCLUDING BICYCLE REGISTRATION AND RELATED FEES, AMENDING LMC 3.104.220, REPEALING LMC 11.56.030, AND PROVIDING FOR AN EFFECTIVE DATE, SEVERABILITY AND SUMMARY PUBLICATION.

WHEREAS, fees for City services are authorized by the Lynnwood Municipal Code (LMC), and are codified as Chapter 3.104 LMC, which is generally referred to as the "Fee Schedule"; and

WHEREAS, the Fee Schedule is revised periodically to address changing conditions; and

WHEREAS, the director of parks, recreation and cultural arts has determined that adjustments to recreation fees are prudent and warranted; and

WHEREAS, LMC 11.56.030, enacted in 1964 and amended in 1973, contains obsolete and unnecessary provisions relating to bicycle registration and the associated \$1.00 fee, which the chief of police has determined no longer serves to advance the public's health, safety, and welfare; and

WHEREAS, the provisions of this ordinance are procedural in nature and are exempt from SEPA threshold determination and EIS requirements as specified by to WAC 197-11-800(19); and

WHEREAS, the City Council has determined that the provisions of this ordinance are in the interest of the public's health, safety and general welfare;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LYNNWOOD, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1: LMC 3.104.220 is amended as provided by Exhibit A to this Ordinance.

Section 2: LMC 11.56.030 is repealed.

<u>Section 3</u>: <u>Effective Date</u>. This ordinance shall become effective five days following passage and publication.

<u>Section 4</u>: <u>Severability</u>. If any section, subsection, sentence, clause, phrase or word of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction,

such invalidity or unconstitutionality thereof shall not affect the validity or constitutionality of any other section, subsection, sentence, clause, phrase or word of this ordinance.

<u>Section 5</u>: <u>Summary Publication</u>. Publication of this ordinance shall be by summary publication consisting of the ordinance title.
