



**ORDINANCE NO. 3429**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LYNNWOOD, WASHINGTON, AMENDING LMC 2.04.020 AND 2.04.030 TO CLARIFY WHEN MEETINGS SHALL OCCUR WHEN FALLING ON A LEGAL HOLIDAY AND ELIMINATING MEETINGS FALLING ON THE FIFTH MONDAY OF THE MONTH; PROVIDING FOR SEVERABILITY; ESTABLISHING AN EFFECTIVE DATE; AND PROVIDING FOR SUMMARY PUBLICATION**

WHEREAS, the City Council desires to clarify when meetings that fall on a legal holiday shall be held, and the Council wishes to eliminate meetings falling on the fifth Monday of the month;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LYNNWOOD, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1: Purpose. The purpose of this ordinance is to clarify when meetings shall occur when falling on a legal holiday and eliminating the meetings falling on the fifth Monday of the month.

Section 2: Amendment. LMC 2.04.020 shall be amended to read as follows:

**2.04.020 Effect of holiday falling on meeting day.**

In the event that a Monday business meeting or work session shall fall on a legal holiday, then in such event, the official meeting night of the city council shall be the Tuesday night following such Monday holiday.

Section 3: Amendment. LMC 2.04.030(A) shall be amended to read as follows:

**2.04.030 Time and place of work sessions.**

A. The city council shall meet on the first, and third, and fifth Mondays and the third Wednesday of each month for work sessions at 6:00 p.m. and continuing until adjournment no later than 9:00 p.m. unless the meeting is extended by a majority vote of the council.

Section 4. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or

39 unconstitutionality shall not affect the validity or constitutionality of any other section,  
40 sentence, clause or phrase or word of this ordinance.

42 Section 5. Effective Date: This ordinance or an approved summary thereof consisting of its  
43 title shall be published in the City’s official newspaper of record and shall take effect and  
44 be in full force five days following its publication.
