1 2 **CITY OF LYNNWOOD** 3 4 **ORDINANCE NO. 3431** 5 6 ΑN ORDINANCE ADDING SECTIONS 2.92.050 7 ENVIRONMENTALLY PREFERABLE PURCHASING AND 8 PRODUCT UTILIZATION RELATING TO ESSHB 1799 TO THE 9 LYNNWOOD MUNICIPAL CODE; PROVIDING FOR 10 SEVERABILITY, AN EFFECTIVE DATE, AND SUMMARY 11 PUBLICATION. 12 13 14 15 WHEREAS, in March 2022, ESSHB 1799 was signed into Washington law to 16 increase the diversion of organic materials to productive uses and to reduce methane 17 emissions caused by landfills; and 18 WHEREAS, RCW 43.19A.150 requires the City to adopt a compost procurement 19 ordinance by January 1, 2023; and 20 WHEREAS, the City continues to assess the use of compost products in its 21 government-funded projects. 22 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LYNNWOOD, 23 WASHINGTON, DO ORDAIN AS FOLLOWS: 24 Section 1. A new section 2.92.050 of the Lynnwood Municipal Code is hereby added to 25 read as follows: 26 2.92.050 Environmentally preferable purchasing and product utilization. 27 City departments shall, to the greatest extent feasible and practicable and in a manner 28 that balances fiscal and environmental stewardship, procure and utilize 29 environmentally preferable materials, products, and services 30 (including construction services) in accordance with the compost procurement 31 requirements of RCW 43.19A.150. 32 Section 7. Severability. If any section, subsection, sentence, clause, phrase or word of this 33 ordinance should be held to be invalid or unconstitutional by a court of competent 34 jurisdiction, such invalidity or unconstitutionality therefore, shall not affect the validity or 35 constitutionality of any other section, subsection, sentence, clause, phrase or word of this 36 ordinance.
