ORDINANCE NO. 6

CITY OF LYNNWOOD

AN ORDINANCE fixing compensation to be paid the City Attorney of the City of Lynnwood, and providing for reimbursement of expenses.

THE CITY COUNCIL OF THE CITY OF LYNNWOOD DO ORDAIN AS FOLLOWS:

AMENDED Ord #98
Sec. 1. The City Attorney shall receive annually a salary in the sum of One Thousand Eight Hundred Dollars (\$1,800.00), the same to be paid in equal monthly installments on the last day of each calendar month.

AMENDED Ord #97
Sec. 2. The City Attorney shall receive an additional allowance not to exceed One Thousand Two Hundred Fifty Dollars (\$1,250.00) in any one year, for the purchase of office equipment, books and office supplies, and employment of secretarial help, upon presentation of a claim therefor, after allowance and approval thereof, by resolution of the City Council, title to office equipment and books shall be vested and remain in the City of Lynnwood.

Sec. 3. The retainer fee paid by the City to the City Attorney as determined by the City Council shall be payment for all legal services performed in connection with or having to do with all city operations in a governmental as distinguished from a proprietary capacity PROVIDED this shall not include representing the City of Lynnwood in any Superior Court action. For such services, the City Attorney shall be paid in accordance with the minimum fee of the Snohomish County Bar Association or as agreed upon by and between the Council and the City Attorney. PROVIDED FURTHER the City Attorney shall be paid a regular fee for all Local Improvement Districts at the rate of two (2) per cent of the total cost of such improvement; PROVIDED FURTHER there shall be a minimum legal charge for any Local Improvement District of not less than One Hundred Fifty Dollars (\$150.00); PROVIDED FURTHER there shall be a maximum charge on any Local Improvement


District regardless of the total cost of the project not to exceed Two Thousand Dollars (\$2,000.00).

The City Attorney shall be paid extra compensation for any work done for the City of Lynnwood when acting in a proprietary as distinguished from a governmental capacity. The hourly rate of such payment shall be agreed upon by and between the City Council and the City Attorney's office; PROVIDED drafting of ordinances, resolutions or orders in connection with proprietary functions shall not be considered to be extras and these services shall be included in the regular retainer fee.

Sec. 4. That the compensation herein provided shall be payable as hereinabove stated for all official duties performed on or after the 30th day of April, 1959.


Sec. 5. This ordinance shall take effect and be in force five (5) days after its passage, approval and legal publication.


